**IN ADVANCE OF THE CONFERENCE:** IF you are **vaccinated** or are **Exempt** from the Vaccination requirement, you can provide Proof of Full Vaccination or an Exemption Statement, in advance of the event. A special sticker will be affixed to your badge, prior to check-in, which notes that you have confirmed your status.

#### **AT THE START OF THE CONFERENCE:**

- If you do not have a sticker on your badge at Check-in, you will need to provide the Hotel with either your Vaccination Card or an Exemption Statement to receive the sticker.
- If you are **un-vaccinated**, you will need to provide the Hotel with written evidence of a Negative COVID-19 test result taken on or after 8am on Jan 31, 2022 if checking in on Feb. 03, 2022, to receive the sticker.
